



### Isingeniso seProjekthi

I-Tendele Mining (Pty) Ltd, ngemuva kwalokhu ezobizwa ngokuthi iTendele, ingabanikazi bemayini yelahle-ianthracite eyaziwa ngokuthi yiSomkhele Anthracite Mine (Somkhele) kusukela ngo-2006. Imayini isendaweni engamakhilomitha angama-22 enyakatho-ntshonalanga yeDolobha IaseMtubatuba, Kwazulu-Natal ngaphansi kukaMasipala Wesifunda uMkhanyakude futhi isebezena ngaphansi koMphakathi wakwaMpukunyoni. I-Tendele yaqala ukusebenza ngo-2007 eSomkhele ngokwamalungelo amaningi okumayina (MR) aphethwe yi-Tendele. U-87% wabasebenzi uvela emphakathini osingethe lomsebenzi.

Ngomhlaka 26 Okthoba 2016, iTendele yanikezwa ilungelo lokumayina (MR) elinenombolo yerefereensi: KZN30/5/1/2/2/10041MR. Lelilungelo lokumayina (MR) libandakanya indawo engama-222km<sup>2</sup>. I-Tendele isidedele u-92% wendawo kulelilungelo lokumayina (MR). Izindawo ezhloselwe ukumayina manje sezicishe zibe ngama-27km<sup>2</sup>. Izindawo ezigciniwe yisEmalahleni, Ophondweni naseMahujini. iTendele lafaka isicelo seLungelo Lokumayina (MR) ngo-2014, lelilungelo lokumayina (MR) latholakala ngo 2016 (KZN30/5/1/2/2/10041MR), ukutholakala kwelungelo kokumayina (MR) kanye nokugunyazwa kombiko wohlelo lokuphathwa kwemvelo (EMPr) ehambisana nalo kwaphonswa inselelo ngohlelo lokubuyekezwa kwecala. ngokwemibandela yeSigaba 96 soMthetho Wokuthuthukiswa Kwezimbiwa kanye Nophethiloli no. 28 ka2002 (MPRDA) nangokuqulwa kwamacala enkantolo. Mhlaka 4 Meyi 2022, iNkantolo eNkulu yasePitoli yakhipha isinqumo (Umyalelo Wenkantolo) esiphathelene nelungelo lokumayina (MR) kanye ne-EMPr yeTendele.
